**ORDINANCE AMENDING TITLE 13, CHAPTER 13.04 BY ADDING
SECTION 13.04.040 TO THE ORDINANCES OF
THE VILLAGE OF TAMPICO, ILLINOIS**

WHEREAS, the Village of Tampico, Whiteside County, Illinois operates and maintains a waterworks and sewer system which supplies municipal water services treatment services to its users and residents; and

WHEREAS, the Illinois Municipal Code provides the Village with the authority to make, enact, and enforce all needful rules, regulations, and ordinances for the care, and protection of its municipal water supply systems; and

WHEREAS, the Board of Trustees of the Village of Tampico previously passed the required Ordinances, authorizing the Village of Tampico to borrow funds from the Public Water Supply Loan Program; and

WHEREAS, pursuant to the Illinois Environmental Protection Agency loan process authorized by the aforementioned Ordinance, the Illinois Environmental Protection Agency ("IEPA") requires certain language to be added to the Village's Ordinances regarding access to records to ensure compliance with the conditions of any loan or grant pursuant to the program; and

WHEREAS, Title 13 of the Village Municipal Code regulates water service within all areas under jurisdiction of the Village; and

WHEREAS, the Corporate Authorities deem it appropriate to amend Title 13, Chapter 13.04 of the Village Municipal Code by adding Section 13.04.040 entitled Access to Records.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Village Council of the Village of Tampico, Whiteside County, Illinois, as follows:

Section 1. The foregoing reference recitals are made a part and portion of the ordained portion of this Ordinance.

Section 2. Village Ordinance Title 13, Chapter 13.04 is amended by adding to it Section 13.04.040 which shall read in its entirety as follows:

Section 13.04.040 entitled Access to Records:

The Illinois Environmental Protection Agency and the United States Environmental Protection Agency or their authorized representatives shall have access to any books, documents, papers and records of the Village which are applicable to the Village system

of user charges for the purpose of making audits, examination, excerpts and transcriptions thereof to ensure compliance with the terms of the special and general conditions to any state grants and to ensure compliance with the terms of the federal regulations and conditions of any federal grant

Section 3. This ordinance shall be effective after the passage and publication of this Ordinance in pamphlet form.

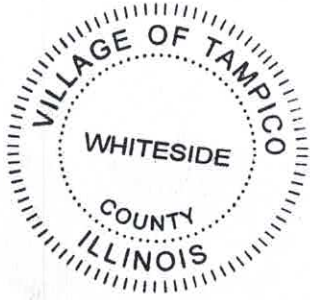
