

**ORDINANCE NO. 003-16-08-16**

ORDINANCE TO AMEND TITLE 9.38  
ENTITLED ADOPTION OF ILLINOIS CRIMINAL CODE  
AND SELECTED ILLINOIS CRIMINAL ACTS

**BE IT ORDAINED** by the Mayor and Village Council of the Village of Tampico, Whiteside County, Illinois, that Title 9, entitled Public Peace, Morals and Welfare, is hereby amended to add Chapter 9.38 which shall read in its entirety as follows and shall be entitled “*Adoption of Illinois Criminal Code and Selected Illinois Criminal Acts*”:

**SECTION 1:**

9.38 ADOPTION OF ILLINOIS CRIMINAL CODE AND SELECTED  
ILLINOIS CRIMINAL ACTS:

9.38.010 Adoption of Illinois Criminal Code: Provisions of the state criminal code, 720 Illinois Compiled Statutes, as may be hereafter amended by the Illinois General Assembly, are hereby adopted and by reference made a part of this chapter with the same force and effect as though set forth herein verbatim.

9.38.020 Adoption of Part of Illinois Drug Paraphernalia Control Act: The Illinois Drug Paraphernalia Control Act, 720 Illinois Compiled Statutes, Act 600, Sections 2, 3.5, 4 and 6, as may be hereafter amended by the Illinois General Assembly, are hereby adopted and by reference made a part of this chapter with the same force and effect as though set forth herein verbatim.

9.38.030 Adoption of Part of the Cannabis Control Act: The Cannabis Control Act, 720 Illinois Compiled Statutes, Act 550, Sections 3, 4, 10 and 16, as may be hereafter amended by the Illinois General Assembly, are hereby adopted and by reference made a part of this chapter with the same force and effect as though set forth herein verbatim.

9.38.040 Violation; Penalty: Any person, firm or corporation that violates any provision of any code or act adopted by reference in this Section shall, upon conviction, be subject to a minimum fine of not less than \$100.00 and the maximum

fine shall not exceed \$750.00. A separate offense shall be deemed committed each day during which a violation occurs or continues. Notwithstanding any provision to the contrary, any person violating the following provisions of the Illinois Criminal Code and the Illinois Drug Paraphernalia Control Act shall be fined not less than the amount listed below set opposite the stated offense:

Injury to Public Property	\$300.00
Possession of Cannabis 2.5-10 grams	\$200.00
Possession of Drug Paraphernalia	\$300.00
Public Fighting	\$500.00
