ORDINANCE AMENDING CHAPTER 11.32.080 OF THE WAUWATOSA MUNICIPAL CODE TO MAKE OPEN PARKING PERMANENT ON SATURDAYS ON CURRIE AVENUE, CURRIE PLACE, PORTLAND AVENUE, GRIDLEY AVENUE, AND AVON COURT, WEST OF ROBERTSON STREET

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The "Currie Avenue - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(c) from Robertson Street west to the dead end"

Part II. The "Currie Avenue - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(t) from Robertson Street west to the dead end"

Part III. The "Currie Place - east side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(c) from end of cul-de-sac to Currie Avenue"

Part IV. The "Currie Place - east side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(t) from end of cul-de-sac to Currie Avenue"

Part V. The "Portland Avenue - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(c) "from Robertson Street to the County Grounds"

Part VI. The "Portland Avenue - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(fff) from Robertson Street to the County Grounds"

Part VII. The "Avon Court - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(c) from Robertson Street, west to the dead-end cul-de-sac"

Part VIII. The "Avon Court - south side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(t) from Robertson Street, west to the dead-end cul-de-sac"

Part IX. The "Avon Court - north side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(c) from Robertson Street, west to the dead-end cul-de-sac"

Part X. The "Avon Court - north side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(t) from Robertson Street, west to the dead-end cul-de-sac"

Part XI. The "Gridley Avenue - north side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(u) from Robertson Street, west to Windsor Court (8300 blocks)"

Part XII. The "Gridley Avenue - north side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(fff) from Robertson Street, west to the cul-de-sac"

Part XIII. This ordinance shall take effect on and after its date of publication.
