

**SUMMARY:** Amends the fees and charges for use of City recreation facilities.

**ORDINANCE NUMBER 828**

AN ORDINANCE AMENDING CHAPTER 3.12 OF THE WINNEMUCCA MUNICIPAL CODE (WMC); AMENDING THE FEES AND CHARGES FOR USERS OF THE CITY RECREATION FACILITIES, INCLUDING THE SWIMMING POOL AND GOLF COURSE; AND, PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

**THE CITY COUNCIL OF THE CITY OF WINNEMUCCA DO ORDAIN AS FOLLOWS:**

**Section 1. Enacting provisions.** There is adopted the following to amend Chapter 3.12 of Title 3 of the Winnemucca Municipal Code.

**1.1 Amendment.** Winnemucca Municipal Code Chapter 3.12.010 is amended to read as follows:

**3.12.010 Recreation Fees.**

A. The following classifications and definitions shall be applicable to this section:

Youth:	Age 5 years through 12 years
Adult:	Age 13 years through 59 years
Senior:	Age 60 years and over
Husband-Wife:	Man and woman, married
Family:	Husband and/or wife and one or more of their children classified as a youth or full time college student.

B. The following persons and organizations are exempt from payment of fees:

1. Community and high school swimming team members for use of swimming pools.
2. Members of the high school golf team for golf play.

C. The rates for use of city swimming pools are as follows:

1. The daily rates for members of the general public are:

Youth:	3.00
Adult:	4.00
Senior:	3.00

2. The annual rates for a city-issued punch card that entitles the cardholder to thirty (30) admissions (one (1) admission per punch) to the swimming pools are:

Adult - general public:	75.00
Youth-senior - general public:	50.00
City-county employees-volunteer fireman:	30.00

A city-issued punch card is valid only during the calendar year in which it is issued and every punch card expires on December 31 of the year it was issued.

3. The rates for swimming pools when rented for private use at times other than normal hours of operation are:

- a. Up to fifty (50) persons, which requires two (2) lifeguards  
For profit: 75.00/hr  
Non-profit: 50.00/hr
- b. Fifty (50) persons or more, which requires three (3) lifeguards  
For profit: 100.00/hr  
Non-profit: 75.00/hr

D. The rates for aquacise instructors providing instruction at the swimming pools are \$25.00 per hour per class.

E. The rates for use of the city golf course are as follows:

1. Daily rates for members of the general public:

	9-Hole Rate	18-Hole Rate
Youth:	10.00	15.00
Adult:	20.00	30.00
Senior:	18.00	25.00

2. Annual rates for members of the general public:

Youth:	200.00
Adult:	525.00
Husband-Wife:	850.00
Family (up to 3):	900.00
Family (4 or more):	1000.00
Senior:	450.00
Senior Husband-Wife (both 60 years or over):	700.00
Senior Husband-Wife (one 60 years or over):	775.00

3. Annual rates for a city-issued punch card that entitles the cardholder to twenty (20) nine-hole rounds (one (1) round per punch) at the golf course:

Youth:	140.00
Adult:	300.00
Senior:	250.00

A city-issued punch card is valid only during the calendar year in which it is issued and every punch card expires on December 31 of the year it was issued.

F. Annual rates for golf cart storage and use at the golf course:

Gas cart:	225.00
Electric cart:	275.00
Trail fee:	75.00
Group rate:	None

G. Rates for use of city softball parks:

1. Team sponsor fee: 325.00
2. Per player fee: 40.00
3. Tournament fees:

- a. Reservation deposit: 50.00, refunded only if tournament is held
- b. Cleaning deposit: 100.00, refunded only if facility is in same condition
- c. Lighting charge: 30.00 per night per field weekends (Saturday-Sunday)
- d. User charge: 60.00 per field per day weekends (Saturday-Sunday)
- e. Field preparation charge: 25.00 per field per preparation

H. Rates for use of recreation center are based upon the type and number of hours of use:

	<u>Profit</u>	<u>Non-Profit</u>	<u>Party</u>
1. Single use, per hour:	15.00	5.00	25.00
2. Monthly use, 5-10 hours/month:	60.00	20.00	
3. Monthly use, 11-15 hours/month:	100.00	40.00	
4. Monthly use, 15-20 hours/month:	125.00	60.00	
5. All or part of the fee for use by public service groups may be waived at the discretion of the City, upon request in writing from the group.			

I. Instructors shall receive revenue for services provided as follows:

1. Gymnastics instructor receives 100% of revenue collected from participants.
2. Karate instructor receives 100% of revenue collected from participants.
3. Aquacise instructor receives 100% of revenue collected from participants.

**1.2 Reenactments.** All other sections of Title 3 of Winnemucca Municipal Code are reenacted without change.

## **Section 2. Concluding Provisions.**

**2.1 Effective Date.** This ordinance shall become effective twenty (20) days after it is published by title together with an adequate summary, including any amendments, once in a newspaper published in the City of Winnemucca and after it is posted in the City Hall, Winnemucca, Nevada.

**2.2 Severability.** If any provisions of this Ordinance or amendments thereto, or the application thereof to any person, thing or circumstance is held to be invalid, such invalidity shall not affect the validity of provisions or applications of the ordinance or amendments thereto which can be given effect without the invalid provision or application and to this end the provisions of this ordinance and amendments thereto are declared to be severable.

**2.3 Repealer.** All ordinances and parts of ordinances in conflict or inconsistent with this ordinance are hereby repealed, but only to the extent of such conflict or inconsistency. The repeal of prior ordinances provided in this section shall not affect any act done or any cause of action accrued or established or any plea, defense, bar or matter existing before the time when such repeal takes effect. No ordinance which heretofore has been repealed shall be revived by the repeals provided in this section.

**2.4 Table of contents, headings and bracketed material.** Any table, listing of section numbers, heading and bracketed material contained in this ordinance are intended as a reference aid and have no legal effect.


