

**Resolution # 16945**

A RESOLUTION of Thurston County, Washington amending the licensing and registration fees of animals in the unincorporated areas of Thurston County.

WHEREAS, Thurston County Municipal Code Chapter 9.10 Animal Control was enacted for the purpose of regulating the keeping of dogs and other animals within the County's unincorporated areas; and

WHEREAS, Thurston County municipal code 9.10.040E authorizes setting licensing and registration fees by resolution of the Thurston County Board of County Commissioner; and

WHEREAS, fees charges and penalties collected are budgeted to assist in defraying the expense of enforcing animal control regulation,

NOW, THEREFORE, BE IT RESOLVED, by the Thurston County Board of Commissioners of Thurston County as follows:


1. The fee changes identified in Exhibit A of this Resolution, attached, shall take effect January 1, 2025.


