

A RESOLUTION OF  
THE GWINNETT COUNTY BOARD OF COMMISSIONERS

**BODY ART STUDIOS AND BODY ARTISTS**

WHEREAS, the Gwinnett County Board of Health adopted rules governing Body Art Studios and Body Artists and a fee schedule for the issuance of permits and inspections on June 13, 2005; and

WHEREAS, the Board of Health desires the ability to enforce these rules through the issuance of citations to Recorders' Court; and

WHEREAS, in order for the Board of Health to have the ability to enforce the rules governing Body Art Studios and Body Artists through citations, the rules must be adopted by the Gwinnett County Board of Commissioners as a duly adopted ordinance of Gwinnett County; and


WHEREAS, any environmental health fees adopted by the Board of Health must be approved by the Gwinnett County Board of Commissioners; and

WHEREAS, the Gwinnett County Board of Commissioners finds that the rules adopted by the Gwinnett County Board of Health governing Body Art Studios and Body Artists are in the best interests of the health and welfare of the citizens of Gwinnett County;


NOW THEREFORE, BE IT ORDAINED this 15<sup>th</sup> day of November, that pursuant to Section 1-3 of the Code of Gwinnett County, Georgia, that the attached ordinance, entitled "Body Art Studios and Body Artists" is adopted as an ordinance of Gwinnett County, and that the same shall be made a part of the Code of Ordinances of Gwinnett County, and the sections of this ordinance may be renumbered to accomplish this intention; and


