**ORDINANCE NO. C- 39 -23  
R- 19 -23**

**WHEREAS**, pursuant to WAC 308-330-270(5) and after an engineering and traffic safety investigation by the County Engineer, the Board of County Commissioners may prohibit, regulate or limit the stopping, standing, or parking of vehicles on any highway; and

**WHEREAS**, the County Engineer has conducted an engineering and traffic safety investigation; and

**WHEREAS**, it has been determined that it is in the public's best interest to prohibit parking on the roads described in Exhibit A; and

**WHEREAS**, traffic control upon County roads is a function of police power exercisable by the Board of County Commissioners; NOW, THEREFORE,

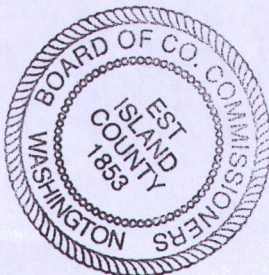
**IT IS HEREBY ORDAINED** by the Board of County Commissioners of Island County, Washington, as follows:


Parking on those portions of the roadways described in the attached Exhibit "A" is hereby prohibited, and the Island County Code is amended to read as written in said Exhibit.  
Material underlined is added and material lined through is deleted.


**THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FIFTEEN DAYS (15) FROM  
AND AFTER ITS PASSAGE INTO LAW.**





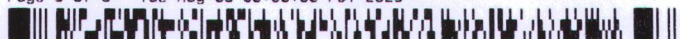

## **TITLE X – VEHICLES AND TRAFFIC**

### **Chapter 10.02 – Road Closures and Restrictions**

#### **10.02.010 – Road restrictions**

...

JJ. Road Restriction – Utsalady Point Road, Road Log #86380. Parking shall be prohibited on both sides of the roadway beginning at MP 0.05 to MP 0.329, Sections 13 and 24, Township 32 North, Range 2 East.

KK. Road Restriction – Shore Drive, Road Log #86450. Parking shall be prohibited on both sides of the roadway beginning at MP 0.00 and ending approximately 360 feet to the north, Sections 13, Township 32 North, Range 2 East.

LL. Road Restriction – 5<sup>th</sup> Street, Road Log #84120. Parking shall be prohibited on both sides of the roadway beginning at MP 0.02 to MP 0.05, Section 34 Township 32 North, Range 2 East.

MM. Road Restriction – Wildrose Lane, Road Log #77510. Parking shall be prohibited on both sides of the roadway beginning at MP 0.104 to MP 0.16, Section 23 Township 31 North Range 2 East.

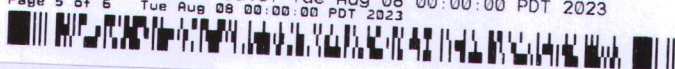
NN. Road Restriction – Mabana Road, Road Log #70590. Parking shall be prohibited on both sides of the roadway beginning at MP 0.00 to MP 0.12, Sections 10 and 15, Township 30 North, Range 3 East.

OO. Road Restriction – Shoreline Drive, Road Log #70900. Parking shall be prohibited on both sides of the roadway beginning at MP 0.00 to MP 1.20, Section 14, Township 30 North, Range 3 East.

PP. Road Restriction – Sundin Drive, Road Log #88850. Parking shall be prohibited on both sides of the roadway beginning at MP 0.59 and continuing east for approximately 70 feet to end of pavement. Section 28, Township 32 North, Range 3 East.

QQ. Road Restriction – Hill Road, Road Log #48430. Parking shall be prohibited on west of the roadway beginning at MP 1.075 to MP 1.23 between the hours of 10:00 PM and 5:00 AM, Section 8, Township 31 North, Range 1 East.

RR. Road Restriction – Glendale Road, Road Log #90070. Parking shall be prohibited on both sides of the roadway beginning at MP 0.00 to MP 0.08, Section 1, Township 28 North, Range 3 East.





SS. Road Restriction – Double Bluff Road, Road Log #23510. Parking shall be prohibited on both sides of the roadway beginning at MP 1.89 to MP 1.96, Section 23 Township 29 North, Range 2 East.

TT. Road Restriction – Shore Avenue, Road Log #23300. Parking shall be prohibited on both sides of the roadway beginning at MP 0.00 to MP 0.072, Section 23 Township 29 North, Range 2 East.


