WHEREAS, an annual reporting has been provided to the Board at work sessions,

WHEREAS, the code should be clarified to represent these annual in-person meetings; and

NOW THEREFORE, BE IT HEREBY RESOLVED by the Board of County Commissioners of Island County, Washington as follows:

The Island County Code is amended. ICC 15.03.160 is amended to read as contained on the attached "Exhibit A." which is adopted. Material interlineated is to be deleted, and material underlined is to be added.

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT ON JANUARY 1<sup>st</sup>, 2024.





#### **15.03.160 – Annual Report**
