



PLEASE TAKE NOTICE that the following Ordinance was introduced and passed on first reading by the Mayor and Council of the Borough of Califon, County of Hunterdon, State of New Jersey, at a meeting held on October 7, 2019. The Ordinance was then ordered to be published according to law. Notice is hereby given that the said Ordinance will be further considered for final passage at a public hearing to be held on November 4, 2019 at 7:30 pm.; prevailing time, or as soon thereafter as the matter may be reached, at Borough Hall, 39 Academy St., Califon, N.J. 07830, at which time all persons interested shall be given an opportunity to be heard concerning the Ordinance. The opportunity to be heard shall include the right to ask pertinent questions concerning the Ordinance by any resident of the Municipality or any other person affected by the Ordinance. The said ordinance is on file and may be inspected at the office of the Municipal Clerk during regular business hours and copies of the Ordinance shall be made available to members of the general public of the municipality who shall request such copies.

ORDINANCE 2019 -08

AN ORDINANCE AMENDING VARIOUS LICENSE AND PERMIT FEES IN THE BOROUGH OF CALIFON, COUNTY OF HUNTERDON, STATE OF NEW JERSEY

BE IT ORDAINED by the Borough Council of the Borough of Califon in the County of Hunterdon, State of New Jersey, that the Code of the Borough of Califon is hereby amended as follows: (additions thusly, deletions ~~thusly~~)

I. Amend chapter 6.04, ANIMAL CONTROL CODE, section 6.04.040 as follows:

6.04.040 License Fees.

A. The sum to be paid annually for a dog license and each renewal thereof, as required by N.J.S. 4:19-15.3, shall be ~~seven eleven~~ fifteen (\$15.00) dollars for spayed/neutered dogs and fourteen twenty (\$20.00) dollars for non-spayed/neutered dogs, plus such registration fees and additional charges as may be prescribed by law.

B. There shall be a ~~four~~ five dollar late fee per month for dog licenses issued after ~~January 31st~~ February 28th of each year.

II. Amend chapter 5.16, RETAIL FOOD ESTABLISHMENTS, section 5.16.020 as follows:

5.16.020 License Fee and Effective Date.

A. The annual fee for licenses of retail food establishments as defined in Chapter XII of the State Sanitary Code is fixed at ~~one two~~ two hundred twenty-five dollars (\$225.00) ~~125.00~~ per annum.

B. ~~The licenses issued shall be effective for a period of one year, commencing annually on July 1st and renewable for succeeding years thereafter upon payment of the annual fee and ...~~ The license issued shall be effective for a period of one year, renewable for succeeding years thereafter upon completion of the renewal application and payment of the annual fee. Applications for the retail food establishment licenses and the required fee shall be submitted to the Board of Health at least twenty (20) days prior to the date of requested issuance or renewal.

C. The fee for temporary food licenses is seventy-five dollars (\$75.00) for a period of three days or less. The fee for four days or more for a temporary food license is \$125.00.

III. Amend chapter 5.12, RENTAL PERMITS FOR HOUSES AND APARTMENTS, section 5.12.020 as follows:

5.12.020 Application Fee.

B. The fee for the issuance of each permit shall be the sum of ~~ten~~ twenty dollars (~~\$10.00~~ \$20.00) and such fee shall be paid to the ~~building inspector~~ Califon Board of Health representative for making such inspections.

IV. Amend chapter 8.08, INDIVIDUAL SEWAGE DISPOSAL SYSTEMS AND NON-PUBLIC WATER SYSTEMS, sections 8.08.020 and 8.08.180 as follows:

8.08.020 Definitions.

“Board of Health” means the Board of Health of The Borough of Califon, or its duly authorized agent, designee, representative, or health officer, including the ~~Division of Health Services—Environmental Health director or department.~~ Hunterdon County Division of Health Services.

8.08.180 Fees and Charges.

The following fees and charges are established (R.S. 26:3-31) for the filing of an application for a permit:


- A. To locate and construct a new individual subsurface sewage disposal system: ~~\$125.00~~ \$250.00
- B. To locate and construct a new nonpublic water system: \$125.00.
- C. To repair, enlarge remove, or demolish or alter an existing sewage disposal system or an existing nonpublic water system: \$180.00
- D. To witness two percolation tests and one soil boring per lot: ~~\$60.00~~ ~~\$75.00~~ \$125.00
- E. Add \$20.00 – Change (additional hole).


V. Severability. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause of provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

VI. Repealer. All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.

VII. Effective Date. This Ordinance shall take effect after final passage, adoption and publication according to law.


