
ORDINANCE 2018 – 04

AN ORDINANCE AMENDING THE CODE
OF THE BOROUGH OF CALIFON,
COUNTY OF HUNTERDON, STATE OF NEW JERSEY
REGARDING PERMITTED HOURS FOR
CANVASSING OR SOLICITING

BE IT ORDAINED by the Borough Council of the Borough of Califon in the County of Hunterdon, State of New Jersey, that the code of the Borough of Califon, Chapter 5.08 is hereby amended as follows: (additions thusly, deletions ~~thusly~~)

- I. Amend section 5.08.050, **Issuance of license**, subsection D., as follows:
 - D. All canvassing or soliciting shall be conducted between:
 1. Nine a.m and ~~five p.m.~~ nine p.m., or 30 minutes after sunset, whichever is sooner, ~~Monday through Friday;~~
 2. ~~Ten a.m and four p.m., Saturdays;~~
 3. ~~No canvassing or soliciting shall be permitted on Sundays or holidays.~~
- II. Severability. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause of provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- III. Repealer. All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
- IV. Effective Date. This Ordinance shall take effect after final passage, adoption and publication according to law.




