**AN ORDINANCE AMENDING
TITLE 4 OF THE CITY CODE OF THE CITY OF SHELBYVILLE,
SHELBY COUNTY, ILLINOIS**

WHEREAS, Title 4 of the City Code of the City of Shelbyville addresses several aspects of the City's liquor ordinances; and

WHEREAS, it has been determined that it is in the best interest of the of the public to amend the aforementioned Title regarding the issuance of Class A liquor licenses in the City of Shelbyville; and

WHEREAS, this Ordinance shall take effect upon its passage and publication in pamphlet form.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHELBYVILLE, ILLINOIS:

SECTION I: That Title 4-4-17 of the City Code of the City of Shelbyville be, and is hereby amended to states as follows:

4-4-17: NUMBER OF LIQUOR LICENSES: The maximum number of licenses that may be issued for the respective classes as set forth in Section 4-4-4 and outstanding at any time is hereby set as follows:

Class A License	not more than 5 licenses
Class B License	not more than 3 licenses
Class C License	not more than 1 licenses
Class D License	at the direction of the Local Liquor Commissioner
Class E License	not more than 3 licenses
Class F License	not more than 4 licenses
Class G License	not more than 0 licenses
Class H License	not more than 3 licenses
Class I License	not more than 4 licenses

SECTION II: The changes to the City Code shall be in full force and effect from and after the passage, approval and upon publication in pamphlet form of this Ordinance, as provided by law.


