

**ORDINANCE 2022-41**

**AN ORDINANCE OF THE CITY OF MEADOWS PLACE, TEXAS, PROVIDING FOR A SCHEDULE OF FEES; UPDATING FEES FOR WATER SERVICE RATES AND SANITARY SEWER SERVICE RATES; WATER AND SANITARY SEWER TAPS, RESIDENTIAL IRRIGATION RATES, SPECIAL EVENT PERMIT APPLICATION, COMMUNITY CENTER, AND PEDDLER/SOLICITOR APPLICATION REPEALING ALL ORDINANCE OR RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING A PENALTY; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

\* \* \* \* \*

**WHEREAS**, the City Council of the City of Meadows Place, Texas, finds that providing a Schedule of Fees in which all the fees adopted by the City are contained in one centralized document will be easier for city staff to administer and easier for the public to understand;

**WHEREAS**, the City Council of the City of Meadows Place, Texas, now desires to update its Schedule of Fees; and

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MEADOWS PLACE, TEXAS:**

**Section 1.** That the facts found in the preamble are true and correct and incorporated herein for all purposes.

**Section 2.** That all past City of Meadows Place, Texas, actions regarding charging of fees are hereby ratified and approved.

**Section 3.** That the City Council of the City of Meadows Place, Texas, adopts the following changes to Chapters 51, 94, 96 and 111 of the City’s Schedule of Fees, attached herein as “**Exhibit A**”, leaving all other sections within the City’s Schedule of Fees unchanged:

**Section 4.** *Repeal.* All ordinances and resolutions in conflict herewith are hereby repealed.

**Section 5.** *Penalty.* Any person who violates or causes, allows or permits another to violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine of not more than five hundred dollars (\$500.00). Each occurrence of any such violation of this Ordinance shall constitute a separate offense. Each day on which any such violation of this Ordinance occurs shall constitute a separate offense.

**Section 6.** *Severability.* In the event any clause, phrase, provision, sentence or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Meadows Place, Texas, declares that it would have passed each and every part of the same

notwithstanding the omission of any part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

**Section 7.** *Effective date.* This Ordinance shall become effective July 27, 2022 and enforceable when published as required by law.
