ORDINANCE NO. 2024-01

**AN AMENDMENT TO THE ZONING ORDINANCE TO PROVIDE REGULATION OF
ACCESSORY BUILDINGS**

CEDAR CREEK TOWNSHIP ORDAINS:

Section 1. Chapter 3 of the Cedar Creek Zoning Ordinance, entitled Accessory Buildings, Structures and Uses is hereby amended to delete existing 3.2A4, to renumber accordingly, and to read as follows:

3.2.A. Accessory Buildings, General

1. Where an accessory building is attached to a main building, it shall conform to all regulations of this Ordinance applicable to the main building.
2. Accessory buildings shall not be located in any required front yard, unless otherwise permitted by this Ordinance.
3. Accessory buildings shall not be permitted on a lot or parcel which does not have a main use or building.
4. Permanent accessory buildings shall be stick-built or the equivalent new building construction. No mobile home, tank, junk object, or salvage materials, trailer, vehicle or similar item shall be utilized as an accessory building; provided, however, that such requirement shall not be applicable to bona fide agricultural storage or activities, or to tool sheds or similar temporary storage structures utilized pursuant to the construction of a building, so long as the period of construction does not exceed one year.

5. Manufactured temporary structures shall be allowed, up to two per lot or parcel. (New 9/23/02)

6. One temporary building may be placed in the required front yard for use as a bus stop shelter for school children. (New 11/1/06)

Section 3. Publication; Effective Date. This ordinance shall be effective seven (7) days after publication of a summary of its provisions in a local newspaper of general circulation in the Township.
