

CITY ORDINANCE NO. 4912

AN ORDINANCE OF THE CITY OF LEWISTON REPEALING AND RESERVING SECTION 7-6 OF THE LEWISTON CITY CODE RELATED TO THE LEWISTON EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AMENDING SECTION 2-42(c) REGARDING THE MEMBERSHIP OF THE EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AMENDING SECTION 2-49(c) REGARDING THE POWERS AND DUTIES OF THE EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEWISTON, IDAHO:

SECTION 1: Lewiston City Code § 7-6, "Advisory Board" is hereby repealed in its entirety and reserved for future use.

SECTION 2: Lewiston City Code § 2-42(c) is hereby amended as follows:

**Sec. 2-42. Terms, appointment, membership, vacancies, and reappointments.**

...

(c) *Membership.* Unless otherwise provided by law or elsewhere in this section or Code, each advisory board and commission shall choose whether to have five (5), seven (7), or nine (9) members.

...

(5) *Emergency medical services advisory board.* The emergency medical services advisory board (EMSAB) shall have seven (7) members. One (1) member shall represent the Lewiston Fire Department. One (1) member shall represent St. Joseph Regional Medical Center. One (1) member shall represent the private health care sector. One (1) member shall represent the extended care facility industry. The remaining members shall be from the general public.

SECTION 3: Lewiston City Code § 2-49(c) is hereby amended as follows:

**Sec. 2-49. Powers and duties.**

...

(c) *Emergency medical services advisory board.* The emergency medical services advisory board shall have the following powers and duties; set forth in section 7-6 of this Code.

(1) Advise and make recommendations to the city council on matters that affect the provision of emergency and nonemergency ambulance services within the city.

(2) Review applications for a certificate of compliance and make recommendations to the city council on the same.

(3) Annually review the overall performance of emergency and nonemergency ambulance service providers, ensure the highest quality of patient care, and suggest methods to improve service delivery and minimize costs.

(4) Advise and make recommendations to the city council on the development of rules and policies governing ambulance service providers.

(5) Hear and investigate complaints against ambulance service providers.

(6) Perform such other emergency medical services related tasks as the city council shall designate.

SECTION 4: This ordinance shall take effect and be in full force from and after its passage and publication.

**ORDINANCE NO. 4912: AN ORDINANCE OF THE CITY OF LEWISTON REPEALING AND RESERVING SECTION 7-6 OF THE LEWISTON CITY CODE RELATED TO THE LEWISTON EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AMENDING SECTION 2-42(c) REGARDING THE MEMBERSHIP OF THE EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AMENDING SECTION 2-49(c) REGARDING THE POWERS AND DUTIES OF THE EMERGENCY MEDICAL SERVICES ADVISORY BOARD; AND PROVIDING AN EFFECTIVE DATE.**

Section 1 repeals and reserves Lewiston City Code § 7-6 related to the Emergency Services Advisory Board (EMSAB). Section 2 amends Lewiston City Code § 2-42(c) to add the membership criteria for the EMSAB. Section 3 amends Lewiston City Code § 2-49(c) to list the powers and duties of the EMSAB. Section 4 provides an effective date.

Ordinance No. 4912 is effective upon passage and publication.


