**ORDINANCE NO. 22-329**

Commissioner Brandsen, supported by Commissioner Groot, moved the adoption of the following ordinance:

**AN ORDINANCE AMENDING, CONSOLIDATING, AND RESTATING  
THE CITY OF HUDSONVILLE ZONING ORDINANCE AND THE CITY  
OF HUDSONVILLE DOWNTOWN ZONING ORDINANCE**

**THE CITY OF HUDSONVILLE ORDAINS:**

**Section 1. Amendment, Consolidate, and Restatement of the City of Hudsonville Zoning Ordinance and City of Hudsonville Downtown Zoning Ordinance.** “The City of Hudsonville Zoning Ordinance,” as adopted by the City of Hudsonville City Commission on September 8, 1992 and all subsequent amendments thereof, and the “City of Hudsonville Downtown Zoning Ordinance,” as adopted by the City of Hudsonville City Commission on January 10, 2012 and all subsequent amendments thereof, are hereby amended, consolidated, and restated in their entirety to read as set forth in Exhibit A attached hereto, which is incorporated by reference and shall become Appendix A of the Code of Ordinances, City of Hudsonville, Michigan.

**Section 2. Effective Date.** This ordinance shall take effect 7 days after its publication, or a summary thereof, in a newspaper of general circulation in the City.

**Section 3. Publication.** After its adoption, this ordinance or a summary thereof, as permitted by law, shall be published by the City Clerk in *The Grand Rapids Press*, a newspaper of general circulation in the City.
