AN ORDINANCE AMENDING  
TITLE 3, “BUSINESS AND LICENSE REGULATIONS”,  
OF THE BARRINGTON VILLAGE CODE

(RE: Amendments to Section 3-3-8, “Number of Licenses; Fees”  
of Chapter 3, “Liquor Control”)

WHEREAS, the Village of Barrington, Cook and Lake Counties, Illinois (hereinafter, the “Village”), pursuant to the laws of the State of Illinois (235 ILCS 5/4-1) and pursuant to the Home Rule authority of this Village, is empowered to regulate the sale, possession, and delivery of alcoholic liquor and from time to time limit the number of liquor licenses it authorizes and issues and make other modifications to its Village Code; and

WHEREAS, the Corporate Authorities of the Village desire to amend the provisions of Chapter 3 of Title 3 of the Barrington Village Code as hereinafter set forth:

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, in exercise of its authority as a Home Rule unit of government, as follows:

SECTION 1: The President and Board of Trustees hereby find that the recitals hereinabove set forth are true and correct and are incorporated into the text of this Ordinance as its findings to the same extent as if each such recital had been set forth herein in its entirety.

SECTION 2: Paragraph A of Section 3-3-8, “Number of Licenses”, of Chapter 3, “Liquor Control”, of Title 3 of the Village of Barrington Village Code is hereby amended to read as follows:

“3-3-8: NUMBER OF LICENSES; FEES:

- A. There shall be issued in the Village not more than twenty-six (26) Class 1-A Licenses, eight (8) Class 1-B Licenses, thirteen (13) Class 2-A Licenses, eight (8) Class 2-B Licenses, no (0) Class 3 Licenses, no (0) Class 4 Licenses, two (2) Class 5 Licenses, and one (1) Class 6 License, as set forth below:

SECTION 3: The Corporate Authorities of the Village intend that this Ordinance will be made part of the Village Code and that sections of this Ordinance can be renumbered or relettered and the word "Ordinance" can be changed to "Section", "Article", "Chapter", or some other appropriate word or phrase to accomplish codification, and regardless of whether this Ordinance is ever codified, the Ordinance can be renumbered or relettered and typographical errors can be corrected with the authorization of the Village Attorney, or his or her designee.

SECTION 4: If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance or any part thereof is, for any reason, held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of

the remaining portions of this Ordinance, or any part thereof. The Corporate Authorities hereby declare that they would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentence, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 5: This Ordinance shall immediately be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION 6: The Village Clerk is directed to immediately publish this Ordinance in pamphlet form.
