**AN ORDINANCE  
AMENDING TITLE 7: BUILDING REGULATIONS, CHAPTER 1: CODES;  
SECTION 7-1-8: INTERNATIONAL SWIMMING POOL AND SPA CODE**

WHEREAS, the Corporate Authorities have previously updated and amended the regulations governing swimming pools and spas to be installed on properties within the Village, as of 2022; and

WHEREAS, at that time, on the recommendation of the Village Building Official, the Corporate Authorities adopted the International Swimming Pool and Spa Code, with various amendments; and

WHEREAS, by one such amendment to be applicable in the Village, the Code was at that time modified so as to preclude the use of safety pool covers in lieu of or as a substitute for fencing or other appropriate barrier around a swimming pool to be installed in the Village; and

WHEREAS, the President and Village Board of Trustees have reconsidered the matter of allowing safety pool covers, and find that precluding such covers is not necessary, and that safety pool covers ought to be allowed as provided in and subject to the requirements of the International Swimming Pool and Spa Code.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SLEEPY HOLLOW, COUNTY OF KANE, STATE OF ILLINOIS, AS FOLLOWS:

Section 1: The Sleepy Hollow Municipal Code, as amended, shall be and is hereby further amended to modify the provisions of the International Swimming Pool and Spa Code previously adopted in Section 7-1-8 of the Sleepy Hollow Municipal Code, to delete the amendment of Section 305.1 of the Swimming Pool and Spa Code previously approved in Section 7-1-8(B)(7), thereby restoring the original language of said Code in regard to safety covers for swimming pools and/or spas.

Section 2: The following provision of the International Swimming Pool and Spa Code shall be applicable in the Village:

Section 305     BARRIER REQUIREMENTS

Section 305.1   General.

The provisions of this section shall apply to the design of barriers for restricting entry into areas having pools and spas. Where spas or hot tubs are equipped with a lockable safety cover complying with ASTM F1346, and swimming pools are equipped with a powered safety cover that complies with ASTM F1346, the areas where those spas, hot tubs or

pools are located shall not be required to comply with Sections 305.2 through 305.7.

Section 3: The other amendments to the provisions of the International Swimming Pool and Spa Code adopted in Ordinance No. 2022-15 and set forth in Section 7-1-8(B) of the Sleepy Hollow Municipal Code shall remain in effect.

Section 4: Any motion, order, resolution, or ordinance in conflict with the terms and provisions of this Ordinance shall be and is, to the extent of such conflict, hereby superseded and waived.

Section 5: If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be void, invalid, or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 6: This Ordinance shall be in full force and effect from and after its passage and approval, and publication in pamphlet form, in the manner provided by law.
