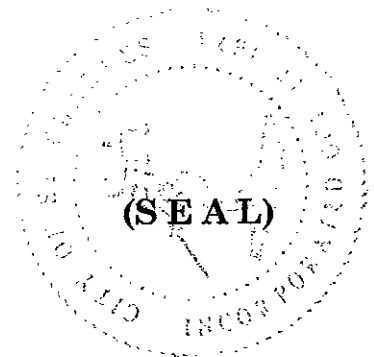

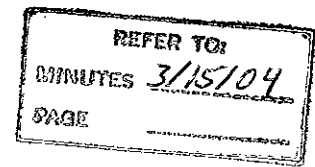
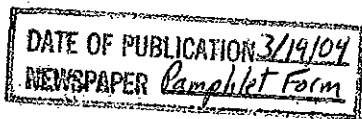

ORDINANCE NO. 2004-M- 20

AN ORDINANCE AMENDING TITLE 5, "BUSINESS LICENSES AND REGULATIONS," CHAPTER 5.08, "ALCOHOLIC BEVERAGES," SECTION 5.08.080, "LICENSE – CLASSES AND FEES," OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 5, "Business Licenses and Regulations," Chapter 5.08, "Alcoholic Beverages," Section 5.08.080, "License – Classes and Fees," of the St. Charles Municipal Code, be and is hereby amended by creating a subclass license Class C1 that reads as follows:

A-2. Class A-2 licenses shall authorize the retail sale of alcoholic liquors in original packages only and not for consumption on the premises. The primary purpose of Class A-2 premises shall be for retail sales other than the sale of alcoholic liquors, such as food store, drug store or mass merchandiser, provided the gross square footage of such premises is 10,000 sq. ft. or larger, and provided the retail alcoholic liquor sales area is 10% or less, of the gross square footage. The alcoholic liquor sales area shall be confined to an area, which is separated from the other retail sales area. The alcoholic liquor sales area shall include means of locking the access during prohibited sales hours.


2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.
