

ORDINANCE NO. 95-11-65

AN ORDINANCE OF THE CITY OF ROYSE CITY, TEXAS,
REQUIRING SWIMMING POOLS TO BE FENCED; PROVIDING
FOR DEFINITIONS; PROVIDING FOR FENCE SPECIFICA-
TIONS; PROVIDING FOR REQUIREMENT FOR BUILDING
PERMIT; PROVIDING FOR A SEVERABILITY CLAUSE;
PROVIDING A PENALTY NOT TO EXCEED FIVE HUNDRED
DOLLARS (\$500.00) AND A SEPERATE OFFENSE SHALL
BE DEEMED COMMITTED UPON EACH DAY DURING OR ON
WHICH A VIOLATION OCCURS; PROVIDING FOR REPEAL
OF A PREVIOUS SWIMMING POOL ORDINANCE, (NUMBER
128); PROVIDING FOR GENERAL REQUIREMENTS FOR
SWIMMING POOLS; DECLARING AN EMERGENCY AND
PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF ROYSE CITY, TEXAS:

Section 1. DEFINITIONS:

A swimming pool shall be any pool, hot tub, or spa,
either above or below the ground, containing or capa-
ble of containing water to a depth of one and one-half
feet, or more.

Section 2. POOLS TO BE FENCED

Every person in possession of land within the corporate
limits of the City of Royse City, Texas, either an
owner, purchaser under contract, lessee, or tenant, upon
which is situated a swimming pool, shall at all times
maintain upon the lot or premises on which the swimming
pool is located a fence, wall, or other structure
designed to prevent small children from inadvertently
wandering into the pool. Such fence or other structure
shall be not less than five (five) feet in height, with
no openings therein, other than doors or gates, larger
than four (4) inches, measured in a horizontal direction
and not more than a three (3) inch opening between the
ground or surface and the bottom of said fence, wall or
structure, and designed and constructed so as not to be
easily climbable. All such doors, opening directly into
such enclosure shall be equipped with self-closing and
self-latching devices designed to keep, and capable of
keeping, such doors, and gates securely closed at all
times when not in actual use, such latching device to
be attached to the upper quarter of such door or gate,
provided however, that the door of any dwelling
occupied by human beings and forming any part of the
enclosure herein required need not be so equipped, if
transparent. It shall be unlawful to maintain any
swimming pool in the corporate limits of the City of
Royse City, which is not fenced in accordance with the
requirements of this section.

Section 3. PERMIT REQUIRED

A building permit is required for the construction of swimming pools with the City, and plans for each swimming pool and enclosure therefore shall show compliance with the requirements of this ordinance before a building permit may be issued.

Section 4. REPEALER

Ordinance number 128 of the City of Royse City, is hereby repealed.

Section 5. GENERAL REQUIREMENTS

- (1) All pools shall be equipped with a filtration system large enough to completely circulate the water once every six (6) hours.
- (2) All pools shall be equipped with a chlorination system.
- (3) No pools shall be drained, either partially or completely, except by connection to the sanitary system of the City. If the pool does not have an existing connection to the sanitary system, the owner must contact the building official of the City to arrange for the drainage, which will be done at the owners expense. *water expelled by backwashing of no more than 50 gal is exempted.* 
- (4) For pools constructed after the effective date of this ordinance, provision for drainage shall be made to drain the pool into the sanitary system of the City.

Section 6. SEVERABILITY

If any section, article, paragraph, sentence, clause, phrase or word in this ordinance or application thereto any person or circumstance is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of the ordinance; and the City Council hereby declares it would have passed such remaining portions of the ordinance despite such invalidity, which remaining portion shall remain in full force and effect.

Section 7. PENALTY


Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in a sum not to

exceed Five Hundred Dollars (\$500.00), and a separate offense shall be deemed committed upon each day during or on which a violations occurs or continues.

Section 8. DECLARING AN EMERGENCY

The fact that the present ordinances of the City of Royse City are inadequate to protect the health and welfare of the inhabitants of the city of Royse City creates an urgency and an emergency and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of its caption as the law in such cases provides.
