ORDINANCE NUMBER 787

AN ORDINANCE AMENDING SECTION 2-273 OF THE NEDERLAND MUNICIPAL CODE CONCERNING PLANNING COMMISSION MEMBERSHIP

WHEREAS, the Town of Nederland, Colorado ("Town") is a statutory municipality, duly organized and existing under the laws of the state of Colorado; and

WHEREAS, pursuant to C.R.S. § 31-23-203(4), the Town Board of Trustees ("Board") is authorized to establish the size, membership, designation of alternate membership, terms of members, removal of members and filling of vacancies of a Town Planning Commission; and

WHEREAS, pursuant to this authority, the Board previously acted, by ordinance, to establish a Town Planning Commission and, by subsequent ordinances, to amend certain aspects of the same; and

WHEREAS, the membership of the Planning Commission is set forth and codified under Section 2-273 of the Nederland Municipal Code ("Code"); and

WHEREAS, the Board now wishes to amend and increase the membership of the Planning Commission.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Nederland, Colorado, as follows:

Section 1. Subsection 2-273(a) of the Code, concerning Planning Commission membership, is hereby amended as follows:

(a) The membership of the Planning Commission shall consist of ~~eight~~ **nine (9)** residents of the Town. One (1) member shall be a member of the Board of Trustees appointed by the Mayor with the approval of the Board of Trustees, with the term to coincide with the member's term as Trustee. This member shall vote only in the event of a tie vote among the other members **and only upon matters of legislative concern.** ~~Six (6) members shall be residents of the Town.~~ The terms of such resident members shall be four-year staggered terms. One (1) said member may be a member of the Board of Zoning Adjustment. It is the intent of the Board of Trustees to encourage diversity of participation on the Planning Commission by avoiding overlapping of membership between the Planning Commission and other boards and commissions of the Town. To initiate the staggered terms, two (2) terms shall expire June 1, 1997, two (2) shall expire June 1, 1998, and the other two (2) shall expire June 1, 1999.

Section 2. Any and all Ordinances or Codes or parts thereof in conflict or inconsistent herewith are, to the extent of such conflict or inconsistency, hereby repealed; provided, however, that the repeal of any such Ordinance or Code or part thereof shall not revive any other section or part of any Ordinance or Code provision heretofore repealed or superseded.
