ORDINANCE NO. 4 (SERIES OF 2025)

AN ORDINANCE OF THE BOARD OF TRUSTEES FOR THE TOWN OF FAIRPLAY DESIGNATING AUTOMATED VEHICLE IDENTIFICATION CORRIDORS

A. The Town currently utilizes Automated Vehicle Identification Systems (AVIS) to detect speeding violations as authorized under C.R.S. § 42-4-110.5 and Chapter 8 of the Fairplay Municipal Code.

B. Vehicle travel at speeds higher than the posted speed limit poses a public safety problem. Last year, the Town experienced a record-high number of fatal and injury collisions, many of which were associated with people driving beyond posted speed limits.

C. C.R.S. § 42-4-110.5 and Chapter 8 of the Fairplay Municipal Code permits the use of unmanned speed enforcement through AVIS to allow detection of speed violations on sections of roadways designated by the Town of Fairplay's Board of Trustees (Board) as Automated Vehicle Identification Corridors (Corridors).

D. Pursuant to Chapter 8, Article 4 of the Fairplay Municipal Code, the Town's Board is authorized to designate by Ordinance specific Corridors for speed enforcement on Town streets, on state highways in coordination with the Colorado Department of Transportation and on county roads with notification to the Colorado State Patrol.

E. The designation of Corridors throughout the Town will help promote traffic safety through speed enforcement and furthers the Town Board's goal of eliminating Fairplay roadway fatalities and reducing injury from vehicle crashes.

F. Town staff will provide updates to the Board every two years on the performance of the adopted Corridors. These updates will allow the Board to adjust the Corridor designations as needed.

G. The Town Board's designation of Corridors is based on data collected by Town staff and the Town's police department, which identified the selected Corridors as areas would most benefit from increased enforcement of speed violations.

H. These corridor designations shall remain in effect until modified by future adopted Town Ordinance.


In light of the foregoing recitals, which the Town's Board hereby makes and adopts as determinations and findings, BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR THE TOWN OF FAIRPLAY that the following Corridors shall be established as Automated Vehicle Identification (AVIS) Corridors:

1. Main Street aka North CO State Highway 9 from 39.226502, -106.006032 (the edge of Town Limits on Main Street as of 05/16/2025) to 39.221235, -105.993684 (the center of the intersection with 285).
2. US Highway 285 from 39.229127, -105.988586 (The Intersection of CO Highway 9 and Park County Road 3) to 39.215932, -105.994051 (The south end Town limits on US Highway 285).


