

**CITY OF ROCKY FORD
ORDINANCE #913**

AN ORDINANCE APPROPRIATING SUMS OF MONEY TO VARIOUS FUNDS AND SPENDING AGENCIES IN THE AMOUNTS AND FOR THE PURPOSE AS SET FORTH BELOW FOR THE CITY OF ROCKY FORD, COLORADO FOR THE 2016 BUDGET YEAR.

WHEREAS, on December 8th, 2016, by Ordinance No. 912, Series 2016, the City Council of the City of Rocky Ford adopted the annual budget for the City's 2016 budget year in accordance with the Local Government Budget Law; and

WHEREAS, The City Council has made provision therein for revenues/fund balances in an amount equal to or greater than the total proposed expenditures or planned expenditures from reserves/fund balances as set forth in said budget; and

WHEREAS, it is not only required by law but also necessary to appropriate the revenues provided in the budget to and for the purposes described below so as not to impair the operations of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKY FORD, COLORADO:

That for the 2016 budget year of the City of Rocky Ford, Colorado the following sums are hereby appropriated from each fund for the purposes stated:
