**A RESOLUTION AMENDING CHAPTER 16, ARTICLE II, DIVISION 3  
– COUNTY JAIL, SECTION 16-55.5, OF THE SEDGWICK COUNTY CODE  
INCREASING THE COMMUNITY CORRECTIONS ADULT INTENSIVE  
SUPERVISION PROGRAM FEES**

**WHEREAS**, on the 19<sup>th</sup> day of January, 2000, the Board of County Commissioners of Sedgwick County enacted Resolution No. 5-2000 increasing user fees for the Sedgwick County Community Corrections Program pursuant to K.S.A. 19-101a; and

**WHEREAS**, on the 16<sup>th</sup> day of June, 2010, the Board of County Commissioners of Sedgwick County enacted Resolution No. 98-10, which established Section 16-55.5 and amended the supervision fee for the Sedgwick County Department of Corrections Adult and Juvenile Intensive Supervision Programs; and

**WHEREAS**, on the 10<sup>th</sup> day of June, 2015, the Board of County Commissioners of Sedgwick County enacted Resolution No. 119-2015 and amended the supervision fee for the Sedgwick County Department of Corrections Adult Intensive Supervision Programs; and

**WHEREAS**, the Community Corrections Advisory Board voted unanimously to approve the fee amendments proposed within this resolution; and

**WHEREAS**, it is the desire of the Board of County Commissioners to adopt this Resolution to amend the supervision fee for clients supervised on probation in the Adult Intensive Supervision Program and establish a supervision fee for the Sedgwick County Department of Corrections Drug Court and Veterans Treatment Court Programs.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Section III of Resolution No. 98-10, also referred to as Section 16-55.5, is hereby amended and shall read as follows:**

**SECTION III.** Section 16-55.5 of the Sedgwick County Code shall read as follows:

Section 16-55.5 Supervision Fee.

A one-time supervision fee will be assessed against participants in the Sedgwick County Community Corrections Juvenile Intensive Supervision Program. Such fee shall be in the amount of Fifty Dollars (\$50.00) for persons placed within the Juvenile Intensive Supervision Program.

A one-time supervision fee will be assessed against participants in the Sedgwick County Community Corrections Adult Intensive Supervision Program. Such fee shall be in the amount of Four Hundred and Fifty Dollars (\$450.00) for persons placed within the Adult Intensive Supervision Program.

A one-time supervision fee will be assessed against participants in the Sedgwick County Community Corrections Drug Court Program. Such fee shall be in the amount of Three Hundred and Sixty Dollars (\$360.00) for persons placed within the Sedgwick County Drug Court Program.

A one-time supervision fee will be assessed against participants in the Sedgwick County Community Corrections Veterans Treatment Program. Such fee shall be in the amount of Three Hundred and Sixty Dollars (\$360.00) for persons placed within the Sedgwick County Veterans Treatment Program.

A program participant agreement to pay the supervision fee shall be part of the acceptance criteria for courtesy supervision cases.

A written policy has been developed by the Sedgwick County Department of Corrections for the implementation of a procedure for collecting this supervision fee. Such policy includes a method for the Sedgwick County Department of Corrections to waive or reduce the supervision fee in exigent circumstances and to establish incentive criteria to reward client success.

#### **PUBLICATION AND EFFECTIVE DATE.**

The Sedgwick County Clerk is directed to publish this resolution once in the official county newspaper. This resolution shall take effect upon its publication in the official county newspaper.
