ORDINANCE NO. 2458.2

AN ORDINANCE AMENDING PARAGRAPH 38-181(d)(2) THE PARKING STIPULATION SCHEDULE

WHEREAS, Cudahy Municipal Code (CMC) currently provides for all night parking prohibitions, exemptions and exceptions; and,

WHEREAS, the CMC further provides for a parking stipulation schedule and gives authority to the Police Department to examine administrative and collection costs from time to time; and,

WHEREAS, all night parking exemptions do not fully comport with the public's understanding of holiday all night parking exemption protocols and parking stipulation schedules should more accurately reflect current parking notice and penalties; and,

NOW, THEREFORE, to maintain order on our city streets through regulation of parking, the City of Cudahy, Wisconsin, Common Council does hereby ordain the following:

Section 1.

- 1. **Paragraph 38-73(b)(5)** of the City of Cudahy Municipal Code is hereby deleted and recreated to read as follows:
 - (5) Exemption. The prohibition of subsection (b)(1) of this section shall not apply between Friday evening through Monday morning, and on the days itemized below, to include the following morning of the day listed:
 - a. New Year's Eve Day
 - b. Memorial Day
 - c. July 4th
 - d. Labor Day
 - e. Thanksgiving Day
 - f. Christmas Day
- 2. **Paragraph 38-181(d)(2)** of the City of Cudahy Municipal Code is hereby deleted and recreated to read as follows:
 - (2) Parking stipulation schedule. The police department shall have the authority to determine the administrative costs of enforcement in collection of forfeitures for parking violations under this section, from time to time as may be necessary to adjust the same, and shall keep the municipal court informed of the same, which court shall assess the same against violators, and cause such to be collected along with stipulation, but, in no event, shall such costs be less than the following, which shall also apply to sections 38-69 and 38-73:
 - a. If paid within 15 days of date of issue, \$25.00.

	c.	If paid after 28 days or a first notice has been sent, \$80.00.	
	d.	If paid after 28 days, parking violation shall be referred to the department of transportation for suspension or refusal of registration.	
Section 2.	All or repeal	dinances or parts of ordinance contravening the provisions of this ordinance are hereby ed.	
Section 3.	If any	part or parts of this ordinance are invalid, it shall not invalidate the entire ordinance.	
Section 4.	Clerk	This Ordinance shall take effect upon passage and publication as provided by law, and the City Clerk shall so amend the Cudahy Municipal Code, and shall indicate the date and number of this amending ordinance therein.
