

ORDINANCE NO. 0236-20-ORD

**AN ORDINANCE OF THE LEWISVILLE CITY COUNCIL
AMENDING THE LEWISVILLE CITY CODE, CHAPTER 15,
SECTION 15-35, BY AMENDING THE SPEED LIMIT ON
THE STATE HIGHWAY 121 FRONTAGE ROADS AND
ELIMINATING CERTAIN UNNECESSARY OR
REDUNDANT STREET ENTRIES; PROVIDING FOR A
REPEALER, SEVERABILITY, AND A PENALTY;
PROVIDING AN EFFECTIVE DATE; AND DECLARING AN
EMERGENCY.**

WHEREAS, the City Council of the City of Lewisville, Texas, has determined that for the health, welfare, and safety of its citizens, and upon engineering and traffic investigation studies conducted by the State of Texas and adopted by the City Council of the City of Lewisville, Texas, the speed limit upon the listed highway shall be as stated herein, and therefore, amendments to Chapter 15, Section 15-35 are necessary.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. Chapter 15, Section 15-35, Maximum Speed Limits on Specific Streets, of the Lewisville City Code is hereby amended by deleting the following street entries:

Street/Road/Highway	Extent	Speed (mph)
State Highway 121	From a point being the interchange with Business SH 121, being 1,200 feet northeasterly from F.M. 2281 (Milepost 0.000), thence southwesterly and southerly along SH 121 a distance of 0.750 miles to a point (Milepost 0.750)	55
State Highway 121	Thence continuing along SH 121 in a southerly direction a distance of 0.4508 miles to a point being the Lewisville-Carrollton common boundary (Milepost 1.2008) and	65

State Highway 121	From a point being the centerline of the Elm Fork of the Trinity River and being the Lewisville-Carrollton common boundary (Milepost 3.8845) along SH 121 in a southwesterly direction a distance of 2.891 miles to Denton Tap Road (Milepost 6.7755)	55
State Highway 121 Frontage Roads	From FM 544 to the south city limit	60
State Highway 121 Frontage Roads	From MacArthur Boulevard to Denton Tap Road	60
State Highway 121 Frontage Roads	From Farm to Market Road 544 to Standridge Drive	55

And, in their place, inserting the following street entries:

State Highway 121 Frontage Roads (northbound and southbound)	Beginning at a said point (MP 69.476) being the Lewisville boundary line with Coppell at Denton Tap Road and continuing along State Highway 121 Frontage Roads to a said point (MP 66.855) being approximately 0.27 miles east of Interstate Highway 35E Northbound Frontage Road	50
State Highway 121 Frontage Roads (northbound and southbound)	Beginning at a said point (MP 63.847) being the Lewisville boundary line with Carrollton north of Carrollton Parkway, then continuing along State Highway 121 Frontage Roads to a said point (MP 61.658) being the Lewisville boundary line with The Colony at Standridge	50

SECTION 2. REPEALER. Every ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.

SECTION 3. SEVERABILITY. If any section, sentence, clause, or phrase of this ordinance shall for any reason be held to be invalid, such decision shall not affect the validity of the remaining sections, sentences, clauses, or phrases of this ordinance, but they shall remain in effect.

SECTION 4. PENALTY. Any person, firm or corporation who violates any provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof in the Municipal Court of Lewisville, Texas, shall be subject to a fine of not more than two hundred (\$200.00) dollars for each offense.

SECTION 5. EFFECTIVE DATE. This ordinance shall become effective immediately upon its passage and publication as required by law.

SECTION 6. EMERGENCY. It being for the public welfare that this ordinance be passed creates an emergency and public necessity, and the rule requiring this ordinance be read on three separate occasions be, and the same is hereby waived, and this ordinance shall be in full force and effect from and after its passage and approval and publication, as the law in such cases provides.
