

ORDINANCE NO. 11-10

**AN ORDINANCE OF THE CITY OF BELLE ISLE, FLORIDA,
ESTABLISHING A DATE FOR THE 2012 MUNICIPAL
GENERAL ELECTION AND RUNOFF ELECTION;
PROVIDING FOR SEVERABILITY AND PROVIDING FOR
AN EFFECTIVE DATE.**

WHEREAS, Article VI, Section 6.05 of the City of Belle Isle Charter provides that regular city elections can be held on such date as may be approved by the City Council by the passage of an ordinance receiving a majority plus one vote of those voting on such ordinance, provided such election date must be the same date as is most common for city elections in other cities within Orange County; and

WHEREAS, the 2012 presidential primary election and the county wide general election will be held on January 31, 2012; and

WHEREAS, January 31, 2012 will be the date that most city elections in Orange County will be held; and

WHEREAS, the City of Belle Isle desires to have its 2012 election coincide with the county wide election date.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Belle Isle, Florida, as follows:

SECTION 1. The 2012 regular city election shall be held on Tuesday, January 31, 2012.

SECTION 2. If no candidate receives a majority of the votes for that office, a runoff election shall be held on Tuesday, March 13, 2012.


SECTION 3. This Ordinance applies only to the 2012 city elections and no provision of the Belle Isle Charter or the Belle Isle Code not in conflict with this Ordinance shall be revised hereby, nor shall this Ordinance apply to any other city elections.

SECTION 4. Severability. If any word, phrase, sentence, clause or other portion of this Ordinance is determined to be invalid, void, or unconstitutional, the remainder of this Ordinance shall remain in effect.


SECTION 3. Effective Date. This Ordinance shall become effective upon adoption.
