

CHARTER TOWNSHIP OF BROWNSTOWN
WAYNE COUNTY, MICHIGAN

ORDINANCE NO. 227-16

AN ORDINANCE ADDING SECTIONS 105.2050 (ILLEGAL DUMPING AND LITTERING) AND 105.2075 (COLLECTION AND FINANCIAL ARRANGEMENTS FOR EXTENSIVE MATERIALS) TO THE DISORDERLY CONDUCT ORDINANCE, PROVIDING FOR REPEALER, SEVERABILITY, PENALTIES AND EFFECTIVE DATE.

THE CHARTER TOWNSHIP OF BROWNSTOWN ORDAINS:

Section 1. Part 105, Article 20.5, Section 105.2050, shall now provide:

105.2050 Illegal Dumping and Littering.

It shall be unlawful for any person to knowingly, without the consent of the Township or owner of private property in the Township, dump, deposit, place, throw, or cause or permit the dumping, depositing, placing, throwing, or leaving of garbage, rubbish; refuse; compost; construction waste; auto bodies, tires and parts; or other waste materials on a public or private property or water within the Township.

Section 2. Part 105, Article 20.5, Section 105.2075, shall now provide:

105.2075 Collection and Financial Arrangement for Extensive Materials.

It shall be unlawful for any person to place garbage; refuse; compost; construction waste; tires and parts; or any other waste materials on a public or private property in such an amount or quantity as to cause the Township's disposal contractor to refuse to collect same, or to charge, or attempt to charge the Township for said collection. Each person shall make collection and financial arrangements, if any, with the Township's disposal contractor prior to placing extensive or large amounts of waste materials for collection.

Section 3. Penalty.

Any entity, organization, employee, or person found guilty of this offense shall be deemed guilty of the commission of a misdemeanor and fined in an amount not exceeding \$500.00 or be imprisoned in jail for a period not exceeding 90 days, or be both so fined and imprisoned in the discretion of the court.

Section 4. Repealer.


All ordinances or parts of ordinances in conflict herewith are repealed only to the extent necessary to give this ordinance full force and effect.

Section 5. Severability.


If any article, section, subsection, sentence, clause, phrase, or portion of this Ordinance is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate distinct, and independent provision and such holding shall not affect the validity of remaining portions of the Ordinance, it being the intent of the Township that this Ordinance shall be fully severable.

Section 6. Effective Date; Publication.

This Ordinance was approved and adopted by the Township Board of Brownstown Charter Township, Wayne County, Michigan, on November 15th, 2021, after introduction and a first reading on October 18th, 2021, and publication after first reading as required by Act 359 of the Michigan Public Acts of 1947, as amended. This Ordinance shall be effective immediately upon publication, in The News Herald, a newspaper having general circulation in the Township.


