Amending Sections 38.05(3)(a) and (b) of the Madison General Ordinances to amend application of public notification fee for alcohol licenses.

#### Body

DRAFTER'S ANALYSIS: This ordinance amendment would require that all applications for or amendments to an alcohol licensed establishment be published and subject to the public notification procedures and fee.

The Common Council of the City of Madison do hereby ordain as follows:

- 1. The introductory paragraph of Subdivision (a) entitled "Contents" of Subsection (3) entitled "Application for Licenses" of Section 38.05 entitled "General Licensing Requirements" of the Madison General Ordinances is amended to read as follows:
- "(a) Contents. The City Clerk shall provide an application form for each kind of license or amendment of a license issued under this chapter. Said application shall be in duplicate, in the application be is for a Class A or Class B or Class C license, it shall be signed by the applicant and containing the following information which shall be verified by oath of the applicant. The application shall be filed with the City Clerk."
- 2. Subdivision (b) entitled "Public Notification Fee" of Subsection (3) entitled "Application for Licenses" of Section 38.05 entitled "General Licensing Requirements" of the Madison General Ordinances is amended to read as follows:
- "(b) <u>Public Notification Fee</u>. The applicant <u>shall</u>, for any license <u>shall issued under this chapter or an amendment thereof</u>, at the time of filing the application with the City Clerk, deposit a fee of one hundred dollars (\$100), for a new license application or for a renewal application, shall deposit a fee of forty dollars (\$40.00) for a renewal application at the time of filing the application with the City Clerk. This fee shall cover the costs of publication as required by sub. (d) and as such fee is set forth in Wis. Stats. §§ 125.04(3)(g) and 985.08. This fee shall also include the costs of providing further public notification as set forth in subs. (e), (g) and (h) below. If the costs of providing the public notification required under subs. (d), (e), (g) and/or (h) exceeds one

hundred dollars (\$100), the City Clerk shall bill the applicant for that portion of the cost that is in excess of one hundred dollars (\$100). No application may be processed unless such fee has been posted with the City Clerk and such fee is non-refundable."
